### 1. Call Meeting to Order

A regular meeting of the Board of Trustees of the Tamalpais Union High School District (District) was called to order at 4:55 p.m. in Kreps Conference Room, Redwood High School, Larkspur. A quorum was declared present.

Ms. Loebbaka read the Board Norms. M/S/C (Roenisch/Oppenheim), unanimously, to approve the agenda.

#### **10. Student Trustee Reports**

Lauren Steele, Redwood High School, reported on Homecoming activities, theater, sports, and a Site Council discussion to change the format of Open House.

Charlotte Pearson, Tamiscal, reported on the TEAM Sierra hike, and all school party planning.

Maddy Darragh-Ford, Drake High School, reported on Homecoming activities, field trip concerns, and SLC discussions.

Kara Kneafsey, Tamalpais High School, reported on Homecoming and other school activities. She also announced that 1967 Tam High School alumni Phil Rhodes finished digitally archiving the entire Tam News collection. It is the largest high school newspaper archive in the country, and will allow users to search Tam News on the web. This was a joint project with the Mill Valley Public Library History Room.

#### 11. Trustee Considerations

# A. Take Action on Revision to Administrative Regulation (AR) 6153 - District Sponsored Trips

Mr. Elsen reviewed the changes to the policy, including the third to the last paragraph which refers specifically to Global Studies field trips involving swimming.

Public Comment:

Douglas Mathieux, Drake parent, spoke in support of continuing the Tahiti field trip exchange.

Ryder LeVieux, Drake student, spoke in support of field trips and swimming.

Janine Shaw, Drake parent, spoke regarding swimming on the Tahiti field trip.

The board made note that the changes in Board Policy are intended to protect students and guard against liability. M/S/C (Saavedra/Roenisch), unanimously.

### B. Approve Intradistrict Open Enrollment Capacity for 2020-2021

Dr. Taupier reviewed the annual process to approve the number of Open Enrollment transfers allowed for the upcoming school year. A maximum of 50 transfers per school to Redwood, Drake, and Tam are allowed during the Open Enrollment period for students who live within the District but prefer to attend a school other than their home school. The Board discussed the possibility of lowering the number of transfers, but agreed that there was not a need to restrict transfers at this time. Dr. Taupier will report back next year if transfers begin to affect staffing.

# C. Second Reading of Revisions to Board Policy and Administrative Regulation 5117 Interdistrict Attendance

The BP/AR 5117 was reviewed to limit transfers, and new language will be added to the District website to specify deadlines. M/S/C (Roenisch/Loebbaka), unanimously, to accept the revisions.

#### D. TUHSD Mathematics Placement Presentation

Dr. Taupier reviewed the SB 359 requirements, and provided data to break out demographics of 9th grade student placement in math courses. She also pointed out improvements in the number of CSU/UC a-g math completion rates over the past five years. The goal is for all students to be able to attend college if they choose, and to complete college level coursework if they do. The Board discussed the ways the District is working toward success in that goal.

#### E. Discussion of Enrollment Projections and Potential Parcel Tax Renewal

Dr. Taupier reviewed enrollment growth numbers, which have increased by 35% in the past 11 years. The numbers are projected to continue to increase through 2020, before dropping down slightly. Projections are used to budget for staffing, and have

been accurate. There have been no changes to the budget projections for the next three years, based on this enrollment information.

#### F. Discuss and Review Board Self-Evaluation

The Board discussed areas of concern identified in the survey and how to improve as an effective governance team. The board would like to review board policy updates from CSBA as an agenda item, to become more involved and efficient in the process. Ms. Harlander would like the board to be even more involved in community partnerships to gather feedback and concerns.

#### **G. Review of Governance Handbook**

The Board looked at Topic 6 and discussed the protocols for responding to email. They also discussed Topic 4 regarding communications to a quorum of the board and corrected a typo. For Topic 7, the third protocol was changed to add the superintendent, as well as the principal, to be notified in advance of school visits.
