Multiple Uses of Same Facilities

The Direct Costs fee for public non-profit youth groups and non-profit community recreational and cultural groups shall be reduced by 25 percent per use for the 10th through 30th use of the same facility (except fields) in a school year if multiple use (i.e., first through up to 30th use) is requested in a single application and approved.

Profit Groups

Fees charged for all district facilities will be at market value and not less than double the non-profit group scale. These rates shall be adjusted annually upon publication of the Bay Area Consumer Price Index.
